## Governing bodies to meet

MI's governing bodies, the Mekong Institute Council and Mekong Institute Steering Committee, will meet in Khon Kaen on July 8.

These two meetings will provide an opportunity for the steering committee members and council to take into account the regular agendas like operations report and audited annual accounts. In addition the meetings will explore the sustainability of the MI operations in the long term, especially financial contributions from country members, after the six GMS countries approved to support the mandate and mission of MI in the 3rd GMS Summit, which was held in Vientiane, Lao PDR late March, this year.

Other proposals to be raised in the meetings include : 1) the MI's efforts to access to the provincial authorities in the GMS in order to get the opportunities to enhance the capability of the officials working in the provincial authorities, 2) setting up of liaison office in each GMS country to help support and facilitate the working of MI national coordinating agencies for the benefits of MI operations, 3) extending MI services to Guangxi province of PR China which has been included in the framework of GMS economic cooperation since 2005. The possibility of the MI services extension will be explored. It is expected that this meeting would provide the ample opportunities for the committee members and council to give inputs and recommendations an MI operations which will be benefit to the GMS countries at last.

The Council is the supreme decision making body of the Institute. This year, the chairman is Mr. Hoang Viet Khang, the Deputy Director-General of Foreign Economic Relations Department at the Ministry of Planning and Investment, Hanoi, Vietnam.

One representative is appointed by each of the GMS governments and five invited members from relevant organizations form the Council of no more than 12 people. The MI Director is a non-voting member. Dr. Tej Bunnag, Advisor of the Office of His Majesty's Principal Private Secretary, Thailand, serves as the Honorary Advisor.

The primary objectives of the Steering Committee is to provide guidance to the Director and staff on policy, strategy and funding, to submit recommendations to the Council and to appraise the performance of the Institute and its management staff.

It consists of no more than eight members appointed by the Council. At least two-thirds are GMS government representatives and the Director is a nonvoting member.

## Research and Learning Programs

#### Regional Research Development & Methodology

Twenty-one GMS participants and a representative from Guanxhi Province of China attended the "Regional Research Development and Methodology" course. Seven sub-regional research topics were identified, including livelihood of the ethnic minorities, the role of NGOs in combating the trafficking of women and the impact of ecotourism along the North-South Economic Corridor. The course, which ran from March 17 until April 4, was sponsored by NZAID. # Officials trained for environmental sustainability

At the end of May, MI hosted a technical workshop, designed to build the capacity of government officials conducting Environment Performance Assessment (EPA).

Forty-five delegates from the six GMS countries and Guanxhi Province of China attended the five-day workshop, which was organized by the Institute for Global Environment Studies and United Nations Environment Program, with the support of the Asian Development Bank through the GMS Environment Operations Center, Bangkok.

During the workshop, the participants planned national and regional sustainable strategies, assessed their domestic social, environmental and economic situations. They also analyzed the existing national and regional strategies and identified policy gaps.



## Decentralized education planning

MI welcomed 21 government representatives to Khon Kaen on May 26, for a training course on decentralized education planning in the context of public sector reform.

Ms Ibtisam Abu-Duhou, (pictured right) Senior Adviser, the Education Policy and Reform Unit, UNESCO Bangkok, gave the opening address.

The course focused on 'education sector management, international development trends/ approaches, and education sector planning methodologies'.

### Regional tourism seminar

A Training-of-Trainers Seminar on cultural tourism sites' guiding and management was hosted by MI on May 26 and 27. The participants were representatives from the six GMS governments and the United Nations involved in tourism human resources development. The seminar was co-organized by the French Government, UNESCO, UNESCAP and the Institute for Tourism Studies, Macao.
